ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE  
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Avix Technologies, Inc. (Avix), holder of Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 7385, has requested the cancellation of ALEC Certificate No. 7385. Avix has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its ALEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2002. Accordingly, we find it appropriate to cancel ALEC Certificate No. 7385, effective 12/31/02. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.
