Dear Mr. Deterding:

This letter is in response to your March 4, 2003, letter regarding rate case expense for the above referenced docket. Rule 25-30.455(1), Florida Administrative Code, specifies that:

If a utility that chooses to utilize the staff assistance option employs outside experts to assist in developing information for staff or to assist in evaluating staff's schedules and conclusions, the reasonable and prudent expense will be recovered through the rates developed by staff.

The purpose of a Staff Assisted Rate Case (SARC) is to assist small water and wastewater utilities in filing for a rate increase. This assistance is meant to avoid the high level of cost associated with filing a traditional file and suspend rate case. Typically the utilities that qualify for staff assistance do not have a customer base large enough to absorb the high level of rate case expense that can accompany a file and suspend rate proceeding. It is staff's opinion that any rate case expense requested pursuant to Rule 25-30.455(1), Florida Administrative Code, should be kept to an absolute minimum. Staff will be very critical of the rate case expense requested and will only recommend such expenses that staff believes are prudent and reasonable.

Regarding the expenses incurred to date on the transfer docket, staff does not believe these are rate case expenses. These expenses were incurred in association with Docket No. 020867-WS, (transfer docket). As such, these expenses should be included as part of the acquisition cost of the utility, not rate case expense. The fact that staff will be using the transfer audit in order to establish rate base does not change the fact that this audit was necessary for completing the transfer. Staff often relies on prior transfer audits and transfer orders to establish rate base, the cost incurred by the utility in evaluating these transfer audits and transfer orders are not rate case expense, they are expenses associated with the transfer.
