NOTICE IS HEREBY GIVEN that Herbert C. Broadfoot II, Chapter 7 Trustee ("Trustee") of the estate of CRG International, Inc. d/b/a Network One ("Debtor"), has filed the "First Application of Herbert C. Broadfoot II, Chapter 7 Trustee, for Interim Allowance of Compensation and Reimbursement of Expenses" (the "Trustee's Application") on March 13, 2003. In his Application, the Trustee seeks allowance of interim compensation in the amount of \$3,633.50 and \$633.92 for expense reimbursement (totaling \$4,267.42) for the period from his appointment through and including February 27, 2003. The Trustee is submitting this application for the time he spent preserving and disposing of the Debtor's property pursuant to 11 U.S.C. § 506(c) and this Court's Order entered July 15, 2002.

NOTICE IS FURTHER GIVEN that Ragsdale, Beals, Hooper & Seigler, LLP, counsel to the Trustee, has filed the "First Application of Ragsdale, Beals, Hooper & Seigler, LLP ("RBHS"), Attorneys for Chapter 7 Trustee, for Interim Compensation" (the "RBHS Application") on March 13, 2003. In the RBHS Application, RBHS seeks allowance of interim compensation in the amount of \$13,253.00 for the period from its employment as attorneys for the Chapter 7 Trustee through February 27, 2003. RBHS is submitting this application for the time the firm has spent in connection with the preservation and disposition of the Debtor's property pursuant to 11 U.S.C. § 506(c) and this Court's Order entered July 15, 2002.




