**Re: KMC Telecom III LLC Tariff Amendment**

Dear Ms. Bayo:

KMC Telecom III LLC ("KMC"), by its attorneys, hereby respectfully provides notice to the Florida Public Service Commission ("Commission") of KMC's proposed discontinuance of the provision of switched intrastate long distance and toll free service to select customers in Florida.

KMC is currently authorized to provide facilities-based and resold, switched, local exchange and interexchange telecommunications services in the State of Florida.<sup>1</sup> KMC currently provides long distance and toll free services via switched or dedicated facilities, and customers may purchase the services in conjunction with KMC's local service or on a "Standalone" basis. KMC intends to discontinue offering switched intrastate long distance and toll free services to customers who purchase only long distance or toll free service from KMC. Customers who purchase long distance service in addition to or in conjunction with local service from KMC will not be affected.

<sup>1</sup> In Florida, KMC is authorized to provide alternative local exchange telecommunications services pursuant to Certificate No. 7093, granted by the Commission on September 6, 1999. KMC is also authorized to resell interexchange telecommunications services in the State of Florida pursuant to Certificate No. 7092, granted by the Commission on August 3, 1999.


