NOTICE OF PROPOSED AGENCY ACTION  
ORDER APPROVING TRANSFER OF AND NAME CHANGE ON  
ALTERNATIVE LOCAL EXCHANGE TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service  
Commission that the action discussed herein is preliminary in  
nature and will become final unless a person whose interests are  
substantially affected files a petition for a formal proceeding,  
pursuant to Rule 25-22.029, Florida Administrative Code.

On January 24, 2003, OneStar Communications, LLC (OneStar  
Communications) and OneStar Long Distance, Inc. (OneStar LD) filed  
with this Commission a joint request for transfer of and name  
change on Alternative Local Exchange Telecommunications (ALEC)  
Certificate No. 4847 from OneStar Communications to OneStar LD.

OneStar Communications and OneStar LD have complied with Rule  
25-24.815, Florida Administrative Code, regarding the transfer of  
ALEC certificates. We find the transfer to be in the public  
interest and, therefore, approve the transfer. ALEC Certificate

No. 4847 shall be amended to reflect that OneStar LD is the holder of this certificate.

If this Order becomes final and effective, it shall serve as OneStar LD's certificate. OneStar LD should, therefore, retain this Order as proof of certification and as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.345, Florida Statutes.

ALEC providers are subject to Chapter 25-24, Florida Administrative Code, Part XV, Rules Governing Telecommunications Service Provided by Alternative Local Exchange Companies. ALEC providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

Pursuant to Section 364.337(2), Florida Statutes, basic telecommunications service provided by an ALEC "... must include access to operator services, "911" services, and relay services for the hearing impaired." Further, Section 364.337(2), requires that an ALEC's "911" service "... shall be provided at a level equivalent to that provided by the local exchange telecommunications company serving the same area."

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed to both OneStar Communications and OneStar LD for payment by January 30th. Neither the transfer of the certificate nor the failure to receive a RAFs Return notice shall relieve OneStar Communications and OneStar LD from their obligation to pay RAFs for the year 2003.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request for transfer of and name change on Alternative Local Exchange Telecommunications Certificate No. 4847 from OneStar Communications, LLC to OneStar Long Distance, Inc., is hereby approved. It is further

ORDERED that Alternative Local Exchange Telecommunications Certificate No. 4847 shall be amended to reflect that OneStar Long Distance, Inc., is the holder of this certificate. It is further

ORDERED that OneStar Long Distance, Inc.'s Alternative Local Exchange Telecommunications Certificate No. 4847 is subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as OneStar Long Distance, Inc.'s certificate and should be retained by OneStar Long Distance, Inc. as proof of certification and as evidence of the name change. It is further


ORDERED that OneStar Communications, LLC and OneStar Long Distance, Inc. shall remit Regulatory Assessment Fees for the year 2003. It is further

It is further
