

Dear Ms. Merchant:

As promised, I am providing to you and all other parties in this proceeding a status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County. The following activities have occurred:

- (1) The Purchase and Sale Agreement, Reclaimed Water Usage Agreement, and Wholesale Water and Sewer Service Agreement have been finalized by Orange County,
- (2) The three agreements referenced above have been approved by the Board of Directors for the Cooperative and are in the process of being executed by the President of the Cooperative this week,
- (3) An Orange County Board of County Commissioner Section 125.3401 hearing is being scheduled for May 20, 2003 for the Board to approve and execute the agreements,
- (4) Responses to a request for additional information from the St. John's River Water Management District have been filed as of April 28 of this week for the issuance and transfer of the primary Consumptive Use Permit, and


