Dear Mr. Jaeger:

As an update on the status of the reuse plan for Water Oak Utility and its submission to you, I am writing to outline the progress of the Utility and its engineers in moving toward not only construction of these facilities, but updating the filing with the PSC for approval of the Reuse Project Plan.

In accordance with the schedule originally submitted to the staff a little over a year ago, and also included as an attachment to my October 21, 2002 letter to you, the Utility is currently in the process of design and permitting of the system and we expect permitting should be done approximately June 30, 2003 as originally estimated. Construction is set to begin sometime very close to the July 31, 2003 date as included in that prior schedule.

In the time between these two dates, we should be receiving bids. Based upon those bids, we will begin preparing the revisions to the original Reuse Project Plan as submitted, with new rates, charges and costs and will supply those to the Commission staff and to the Clerk's office as soon as they are completed. We hope to have that information re-filed no later than mid August, if not before.
