

4. As indicated in the Testimony of Jerry H. Melendy, Jr. and PGA Schedule A-7 for the period January 1, 2002 through December 31, 2002, Sebring Gas System, Inc. anticipates a final true-up amount for the period January 1, 2002 through December 31, 2002, including interest, and net of the estimated true-up for the same period, to be an overrecovery of \$30,407.
