Docket No. 010812-WS was established to determine the proper disposition of delinquent regulatory assessment fees (RAFs) and penalties, owed by River Ranch L.C. d/b/a River Ranch. By Order No. PSC-03-0518-FOF-WS, issued April 18, 2003, the Commission ordered that the delinquent RAFs, plus associated penalties and interest, be referred to the Florida Department of Financial Services, for permission to write off the accounts as uncollectible.

The period in question is for the years 1998 through 2000, and from January through November of 2001. Accordingly, staff requests that the Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Florida Department of Financial Services to write off the uncollectible RAFs, including penalty and interest, for the periods indicated.
