As you may know, the date on which the Commission will consider the issue involving Public Counsel's motion to enforce the settlement agreement in this docket has been subject to several changes. This has been due in part to the Commission's desire to balance its Agenda conference case load, and in part to the scheduling conflict of a key Progress Energy representative. We were recently advised that this matter has now been scheduled for the May 20th Agenda Conference which, unfortunately, poses an additional conflict for an important Company representative.

Given the importance of this issue to all the parties and in an attempt to ensure no further delay, we would like to ask your consideration of rescheduling the matter to a special Agenda Conference preferably on May 27th, or alternatively on May 23rd, both of which appear to be open on the Commission's calendar. The reason for this request is the unavailability of a key member of the Company's regulatory staff to participate at the Agenda Conference on May 20th or in our preparations for that Agenda. The suggested dates in May appear to the only ones that will avoid a serious conflict on our part. As we previously informed the Commission when this matter was schedule for a special Agenda Conference on June 2nd, the Company's lead counsel and principle speaker at the Agenda will be unavailable in the month of June due to a federal court trial commitment.
