Dear Chairman Jaber:

This letter, pursuant to Rule 25-30.430, Florida Administrative Code, requests approval of a test year for Utilities, Inc. of Eagle Ridge ("Company"). The Company intends to submit an application for general rate relief to the Florida Public Service Commission for its wastewater system located in Lee County, Florida. The Company intends to submit the minimum filing requirements ("MFRs") on or before August 15, 2003.

By Order No. PSC-98-0514-FOF-SU, in Docket No. 951008-SU, the Commission approved the transfer of the facilities and certificate of Eagle Ridge Utilities, Inc., to the Company. That Order confirmed the rate base and rates established in February, 1985 in Order No. 14133 in Docket No. 840320-SU. The Company's last appearance before the Commission was in Docket No. 001820-SU, which approved the transfer of the wastewater system of Cross Creek of Fort Myers Community Association, Inc., a utility not regulated by the Commission, to the Company. By Order No. PSC-01-1792-PAA-SU, the Commission approved the transfer and established rate base for that portion of the wastewater system as of December 31, 2000.

The Company proposes a test year of the year ending December 31, 2002. The Company believes that year is representative of current operations and is a representative period to measure the cost of service and to establish new rates. DOCUMENT WE REPORT
