

Dear Application Recipient:

Enclosed is Florida Power & Light Company's (FPL's) application for certification of the Collier-Orange River #3 230-kilovolt (kV) transmission line project. Certification of this line is sought under the State of Florida's Transmission Line Siting Act, Sections 403.52 through 403.5365, Florida Statutes (TLSA). The line will connect the existing Collier substation near Naples in Collier County to the existing Orange River substation east of Fort Myers in Lee County. The total length of the proposed transmission line corridor to be certified is approximately 53.9 miles.

A schedule for the TLSA proceedings prepared by the Department of Environmental Protection is enclosed for your information. I have also attached a copy of the application distribution list so recipients of this letter can see who within their organization has received the application documents and who has received only copies of this transmittal letter and enclosed schedule of the TLSA proceedings.
