

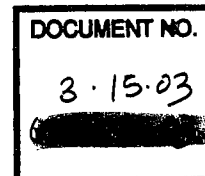
1) The Company is a natural gas utility company within the jurisdiction of this Commission. Its principal business address is:
