

MOTION TO WITHDRAW AS PARTY


ALLTEL Communications, Inc. ("ALLTEL Communications"), pursuant to Rules 25-22.039 and 28-106.205, Florida Administrative Code, hereby requests leave to withdraw as a party in this docket, and states:

1. ALLTEL Communications is a competitive local exchange carrier ("CLEC") company lawfully doing business in the State of Florida pursuant to certificates issued by the FPSC.
2. ALLTEL Communications was granted leave to intervene in this docket by Order No. PSC-99-2152-PCO-TP on November 3, 1999.
3. ALLTEL Communications does not anticipate entering into interconnection negotiations with Verizon in the foreseeable future.
4. ALLTEL Communications has not filed testimony, has not propounded discovery requests to any of the parties, and does not wish to further participate in this docket as a party of record.

5. On May 19, 2003, the undersigned counsel sent an e-mail to the parties of record advising them of ALLTEL Communications' desire to withdraw as a party and inquiring whether any party objected. As of the filing of this Motion, ALLTEL has been advised that BellSouth, Sprint, Verizon, Florida Digital Network and Time Warner do not object. None of the other parties have responded.

WHEREFORE, ALLTEL Communications respectfully requests that the Commission enter an order allowing ALLTEL Communications, Inc. to withdraw as a party of record in this docket.
