BELLSOUTH'S PROPOSED LIST OF ISSUES

BellSouth Telecommunications, Inc. ("BellSouth") submits the following proposed issues:

- 1. What is the Florida Public Service Commission's ("Commission") jurisdiction in this matter, and can the Commission order the relief requested?
- 2. Is BellSouth's \$75 Cash Back Promotion Tariff ("Cash Back Tariff") priced below cost? If so, is the Cash Back Tariff in violation of Sections 364.051(5)(c) and 364.3381, Florida Statutes?
- 3. Does BellSouth's Cash Back Tariff discriminate between "similarly situated customers." If so, is the Cash Back Tariff in violation of Section 364.051(5)(a)?
- 4. Should Supra be allowed to raise issues and ask for a investigation of BellSouth's promotional pricing and marketing practices, including but not limited to Supra's allegations of anticompetitive behavior and CPNI violations, in light of the Commission's decision in Docket No. 020119-TP (Key Customer)?
- 5. Should the Commission attempt to resolve Supra's Complaint via a preliminary agency action ("PAA")?

BellSouth reserves the right to provide additional issues as to proposed Issue No. 4 in the event the Commission decides to initiate a generic investigation into BellSouth's promotional pricing and marketing practices. BellSouth submits that the submission of issues relating to such a generic investigation at this time would be premature.
