**BELLSOUTH TELECOMMUNICATIONS, INC.'S
MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties a ten (10) day extension of time or until July 3, 2003, in which to file their Post-Hearing Briefs. In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on November 26, 2002, Order No. PSC-02-1652-PCO-TP, Post-Hearing Briefs are due on June 23, 2003.

2. Because of other work commitments, BellSouth needs an additional ten (10) days time to file its Post-Hearing Brief in the captioned docket.


3. Neither the parties nor Staff would be prejudiced by a ten (10) day extension of time as Staff's Recommendation is not due until September 4, 2003.

4. BellSouth contacted AT&T Communications of the Southern States, LLC, Teleport Telecommunications Group, Inc., and TCG South Florida ("AT&T's") counsel to ascertain AT&T's position as to BellSouth's request. AT&T informed BellSouth that it does not object to BellSouth's request for an extension. This ten (10) day extension should apply to AT&T as well.


WHEREFORE, for the foregoing reasons, BellSouth respectfully requests that the Commission grant the parties a ten (10) day extension of time or until July 3, 2003 in which to file their Post-Hearing Briefs.
