

ISSUED: June 4, 2003

On October 1, 2002, Utilities, Inc. of Sandalhaven (*Utility*), completed its application to the Florida Public Service Commission (*Commission*) for increased wastewater service rates.

At its regularly scheduled Agenda Conference held on April 15, 2003, the Florida Public Service Commission took action on the Utility's application. By Proposed Agency Action (PAA) Order No. PSC-03-0602-PAA-SU, issued May 13, 2003, the Commission proposed to authorize a portion of the requested increases in wastewater rates designed to allow the Utility the opportunity to recover costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such wastewater service. The Order also authorized a reuse wastewater service rate. The Order was made final May 13, 2003.

The Commission also ordered a refund to customers of 14.11% of the interim rates authorized by Commission Order No. PSC-02-1703-PCO-SU and collected by the Utility pursuant to that Order.

The increased rates approved by the Commission are effective for service on or after June 5, 2003.

The rates prior to filing, the Commission approved interim rates, and the newly approved final rates for wastewater service are listed on the back of this customer notice.
