On April 2, 2003, KMC Telecom Holdings, Inc. ("KMC Holdings" or "Company") filed with the Florida Public Service Commission ("Commission") its applications to engage in a minor *pro forma* internal restructuring involving several of its wholly-owned subsidiaries. Two of those subsidiaries, KMC DATA LLC ("KMC DATA") and KMC Telecom V, Inc. ("KMC V") are currently authorized to provide telecommunications services in Florida.
