

SUPRA'S MOTION FOR LEAVE TO FILE DIRECT TESTIMONY ONE DAY LATE

SUPRA TELECOMMUNICATIONS & INFORMATIONS SYSTEMS, INC. ("Supra"), by and through its undersigned counsel, hereby moves the Commission for Leave to file the direct testimony in this proceeding one day late, and as grounds therefore states:

- 1. Federal Express (Fedex) failed to deliver the necessary documentation and exhibits from Miami, which were required to file Mr. Nilson's complete testimony and exhibits. Using Fedex's tracking program, it indicated a 10:30 am delivery by 3:30pm the package had still not been delivered. We proceeded to process the information at hand to file a partial testimony for Mr. Nilson. Even so, we were unable to timely make the filing with the Clerk's Office. Express); and Supra believes that BellSouth would not be unfairly prejudiced should Supra be granted leave to file its direct testimony one day late.

WHEREFORE, Supra respectfully requests that this Honorable Commission grant it leave to file its direct testimony one day late, and for such other relief as is deemed equitable and just.
