NOTICE OF WITHDRAWAL OF MOTION TO STRIKE PORTIONS OF THE REBUTTAL TESTIMONY AND EXHIBITS OF W. KEITH MILNER

Today AT&T Communications of the Southern States, LLC (AT&T), MCI WorldCom Communications, Inc. and MCIMetro Access Transmission Services, LLC (MCI), ACCESS Integrated Networks, Inc. (AIN), and ITC^DeltaCom Communications, Inc. (ITC^DeltaCom) (Parties) have filed a Notice of Partial Dismissal regarding that portion of the Complaint that deals with BellSouth Telecommunications, Inc.'s (BellSouth) refusal to provide, or continue to provide, FastAccess service to end-users who are served by CLECs via UNE loops (UNE-L). The Parties have also filed a Motion in Limine seeking to prohibit BellSouth from referring to such withdrawn matters. Because the testimony in question appears to relate to UNE-L, because UNE-L issues are no longer the subject of the Complaint, and because the Parties have filed a Motion in Limine asking the Prehearing Officer to preclude BellSouth from addressing or arguing matters related to UNE-L, the motion is unnecessary and the Parties withdraw it. This Notice of Withdrawal moots the need for the Commission to consider the staff recommendation on the Motion at the July 15th Agenda Conference.
