ORDER ESTABLISHING NEW CONTROLLING DATES

On June 21, 2002, Florida Water Services Corporation (FWSC or Utility) filed its petition for Determination of Exclusive Commission Jurisdiction Over Florida Water's Land and Facilities in Hernando County and Application for Original Certificates of Authorization for an Existing Utility Currently Charging for Service. Pursuant to Section 367.045, Florida Statutes, and Rule 25-30.030, Florida Administrative Code, FWSC provided notice, dated June 25, 2002, of its application to the governing body of the county or cities affected, the Office of Public Counsel (OPC), the Commission, and such other persons and in such other manner as prescribed by Commission rule.

In response to FWSC's Notice of Application, on July 25, 2002, Hernando County filed its Notice of Protest of Petition by Florida Water Services Corporation, in which it set forth its arguments against the application filed by FWSC, and also requested a formal administrative hearing pursuant to the provisions of Chapter 120, Florida Statutes. Additionally, on July 15, 2002, Pasco County filed its formal notification of protest to FWSC's application, and in a subsequent letter dated August 5, 2002, requested a formal administrative hearing.

By Order No. PSC-02-1316-PCO-WS, issued September 20, 2002, a procedural schedule was established setting forth the controlling dates for this docket. On October 18, 2002, FWSC filed its First Motion for Continuance. Accordingly, by Order No. PSC-02-1492-PCO-WS, FWSC's Motion for Continuance was granted and new controlling

dates were established for this docket. On April 10, 2003, FWSC filed its Second Motion for Continuance of this docket. By Order No. PSC-03-0508-PCO-WS, FWSC's Motion for Continuance was granted and new controlling dates were once again established.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the

First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
