## **INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT**

This Interconnection, Collocation and Resale Agreement ("Agreement"), entered into and effective this 20<sup>th</sup> day of June, 2003, is entered into by and between KMC Telecom III, LLC, a Delaware corporation and KMC Telecom V, Inc., a Delaware corporation (collectively referred to herein as "CLEC"), and Sprint-Florida, Incorporated ("Sprint"), a Florida corporation (collectively referred to herein as "the Parties"), to establish the rates, terms and conditions for local interconnection, local resale and the purchase of unbundled network elements for the state of Florida.

**NOW THEREFORE**, the Parties agree as follows:

### **1. INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT**

The Parties agree that the Agreement between the Parties shall consist of the Florida Digital Network, Inc. and Sprint-Florida, Incorporated Interconnection and Resale Agreement dated December 27, 2001 (the "Adopted Agreement").

The Parties further agree to adopt and incorporate as part of the Agreement between the Parties, the Florida Digital Network, Inc. and Sprint-Florida Master Collocation License Agreement dated December 27, 2001 (the "Adopted Collocation Agreement").

### **2. PARTIES**

CLEC is hereby substituted in the Adopted Agreement and Adopted Collocation Agreement for Florida Digital Network, Inc. and Sprint shall remain as the other Party to the Agreement.

### **3. TERM**

This Agreement shall have a termination date of December 26, 2003, which corresponds with the termination date of the Adopted Agreement and Adopted Collocation Agreement.




