The Regulatory Assessment Fee (RAF) is due by January 30<sup>th</sup> of each year for the preceding calendar year and is .0015% of a company's intrastate revenues, or \$50.00, whichever is greater. Our records show that the 2002 RAF return form was mailed to us showing revenues in the amount of \$0, but payment for the minimum fee was not included. Since payment is late, statutory penalty and interest charges are applicable.
