COMES NOW the Petitioner TL Fontainebleau Tower Limited Partnership d/b/a Fontainebleau II, by and through the undersigned and files the following reply to Staff's Data Request:

1. No
2. Discussions took place between Lori R. Hartglass, Associate General Counsel for Turnberry Associates and Ken Hoffman, Attorney representing FP&L, by telephone during early April 2003. Written communication from Ms Hartglass to Mr. Hoffman occurred on April 11, 2003. Mr. Hoffman responded outlining FP&L's position by letter dated April 29, 2003.
3. No. Fontainebleau II had interpreted Rule 25-6.049 as exempting facilities that are similar to hotels and motels from the individual metering requirement.

4. Yes. Fontainebleau construction representatives and FP&L employees had numerous conversations about the electrical requirements for Fontainebleau II. FP&L was provided copies of mechanical and electrical blueprints (copies of which are
