Dear Mr. Litchfield:

On May 15, 2003, Florida Power & Light Company (FPL) filed a request for extension of confidential classification granted by Order No. PSC-01-2256-CFO-EI. This Order granted confidential classification for certain materials (Document Nos. 07924-01 and 08307-01) gathered by the PSC audit staff during the FPL Capacity Clause Audit for the Year Ended December 31, 2000, Audit Control No. 01-037-4-1.

A review of this filing reveals a deficiency. The justification table used by the utility in this request for an extension of confidential classification is incorrect. FPL used its June 6, 2001, initial filing to support its request for an extension. FPL updated this filing on August 23, 2001 (Document No. 10502-01). As a result, the utility is requesting a classification extension of the following documents which were not covered by Order PSC-01-2256-CFO-EI: WP 47 (series); WP 48-1/1-6; WP 48-1/1-6/1; WP 49-2 (Page 1 only); WP 53; and WP 53-1/1. These documents are considered public record.


