

RESPONSE: UI does not allocate expenses to its operating subsidiaries. A management decision was made not to allocate expenses to systems that are operated but not owned. Even if those expenses were allocated, the impact would be immaterial.

b. Please explain why Utilities, Inc. does not allocate or bill costs to Charleston Utilities, Inc. located in Mississippi.

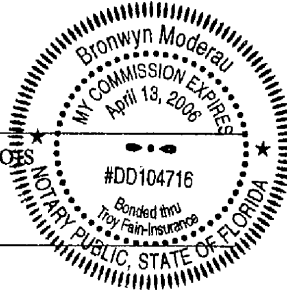
