On May 29, 1999, the Debtor filed a Voluntary Petition for relief under Chapter 11 of the United States Bankruptcy Code and Dan Lain was appointed Chapter 11 Trustee. On January 3, 2000, the case was converted to Chapter 7 and Dan Lain was appointed as the Chapter 7 Trustee ("Trustee").

On July 13, 1999, an order was entered employing Shawn Kevin Brown of the Law Firm of Flynn & Campbell, LLP, as counsel to the Chapter 11 Trustee. Shawn K. Brown, P.C. ("SKBPC") was substituted as counsel for Dan Lain pursuant to an order entered on January 5, 2000. Mr. Brown subsequently became a partner with the law firm of Hance, Scarborough, Wright, Ginsberg & Brusilow, L.L.P. ("HSWGB"). Mr. Brown has continued as counsel to Dan Lain, Chapter 7 Trustee.
