This docket was established on July 16, 2003, for nonpayment of the 2002 Regulatory Assessment Fee. On August 15, 2003, the Division of the Commission Clerk and Administrative Services received notice that the company had filed for Chapter 11 bankruptcy protection. Staff contacted the company's attorney, Mr. Chad Bowen, and asked him to request cancellation of the company's certificate, if the company no longer had need of its certificate. Today, September 15th, I received Mr. Bowen's letter (original letter attached) dated September 12 requesting cancellation of W.G.I. Communications, Inc. d/b/a Boomerang Communications, Inc.'s certificate due to the bankruptcy and requesting that the Commission waive any unpaid Regulatory Assessment Fees. Mr. Bowen also requested that the Commission notify him when this has been done.

Based on the above, please change the docket title to reflect that this is now a bankruptcy cancellation. The docket title should read:

Bankruptcy cancellation by Florida Public Service Commission of CLEC Certificate No. 7880, issued to W.G.I. Communications, Inc. d/b/a Boomerang Communications, Inc., Effective 9/15/03.

In addition to changing the docket title, please document Mr. Bowen's September 12th letter in the docket file, and add Mr. Bowen as an official party to this docket. Let me know if you have any questions.
