- A. FPL recovers the SJRPP capacity costs through the capacity clause, however, pursuant to Commission Order No. PSC-94-1092-EI in Docket No. 940001-EI, an adjustment is made to remove \$56,945,592 from capacity clause recovery to reflect the SJRPP capacity costs included in base rates as a result of the 1988 tax savings docket. Because the 2002 Commission Rate Review was resolved by settlement, there was not an adjustment to remove this amount from base rates.

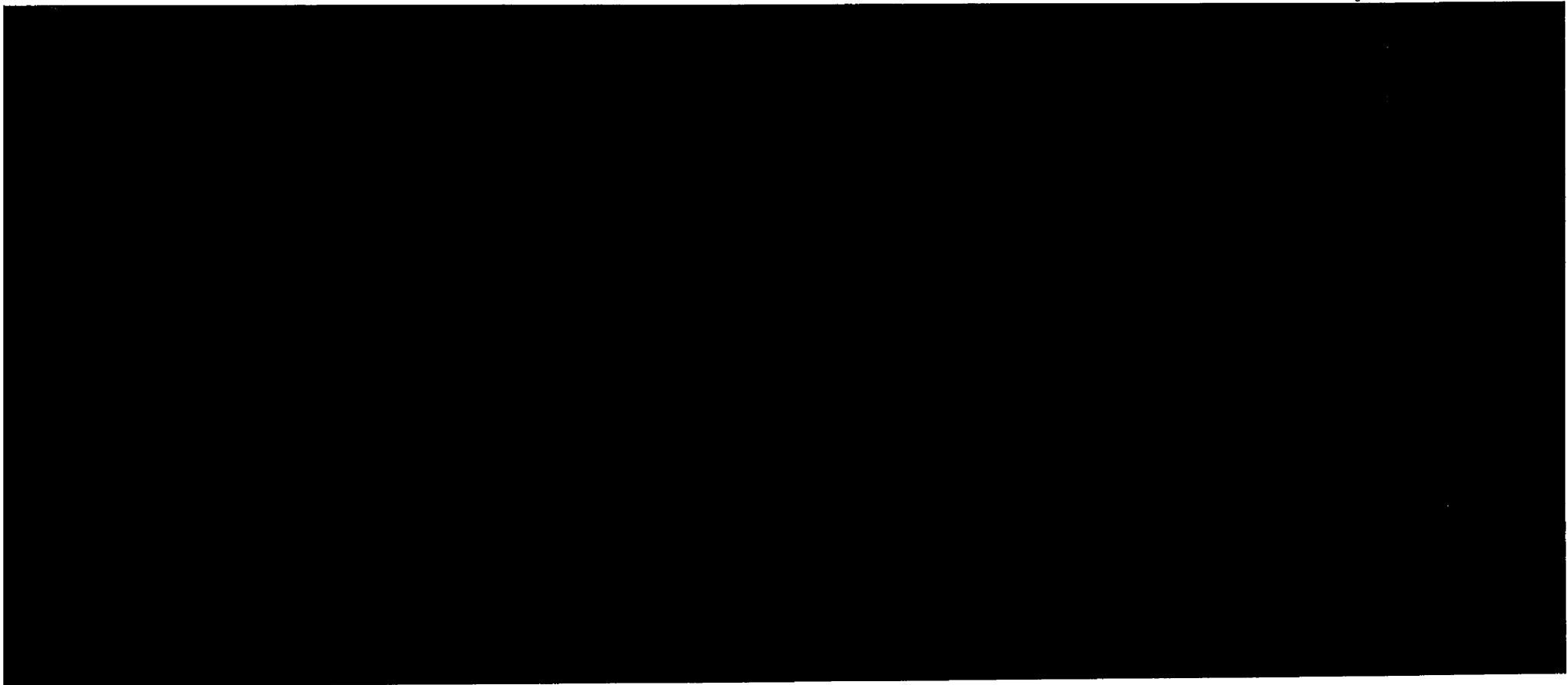

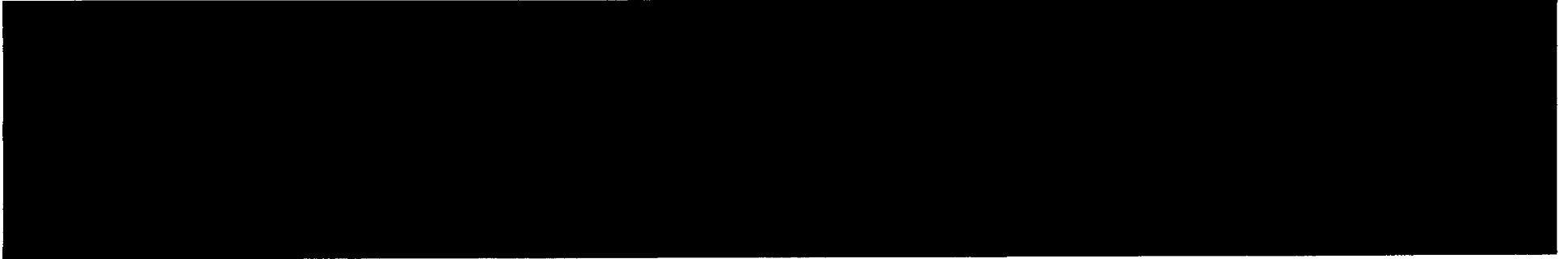
