On August 4, 2003, Florida Power & Light Company ("FPL") filed with the Commission the Petition for Approval of Florida Power & Light Company's Green Power Pricing Research Project. As part of FPL's filing, FPL submitted Original Sheet No. 8.841, the Green Power Pricing - ECCR Rider.

The Staff of the Commission has requested that FPL make several changes to Original Tariff Sheet No. 8.841. In response to Staff's request, FPL is filing the original and fifteen copies of a substitute Original Tariff Sheet No. 8.841. Please substitute this sheet for those filed with FPL's Petition.

The Commission Staff has also asked FPL to clarify two matters regarding its proposed Green Power Pricing Research Project. First, although FPL may end up purchasing some Tradable Renewable Energy Credits ("TRECs") from facilities located outside Florida, FPL has a preference for affordable TRECs from facilities located within Florida. Second, FPL has committed to the development or purchase of 150 kW of photovoltaic facilities within Florida for every 10,000 customers that are added to FPL's Green Power Pricing Research Project. FPL has made these representations to the Staff, is prepared to honor these commitments, and would be comfortable for this to be reflected in any order approving the Project.

GREEN POWER PRICING - ECCR RIDER

AVAILABLE.

In all territory served by the Company This Green Power Pricing – ECCR Ridet ("Green Power Ridet") is limited to customers receiving service under the Residential Service (RS-1) rate schedule. Service under this schedule shall terminate on December 31, 2006, unless extended by order of the Florida Public Service Commission, or terminated earlier by the Company upon notice to the Florida Public Service Commission.

APPLICATION

Applicable, upon request, to Residential Service (RS-1) customers and in conjunction with the Residential Service (RS-1) rate schedule

CHARACTER OF SERVICE

Customers shall purchase renewable energy credits associated with 1,000 kWh of power produced from photovoltaic facilities, facilities utilizing bromass fuel, facilities using land-fill gas, facilities using wind, ocean currents, tides and other hydrological applications, and other renewable energy sources ("Green Power Credits") as approved by the Company

LIMITATION OF SERVICE.

Customers requesting service under this rider will be accepted on a first-come, first-served basis subject to availability of Green Power Credits. If additional Green Power Credits are not available, customers requesting service under the optional rider may request their name be put on a waiting list until additional Green Power Credits can be secured to serve their request. Any residential Customer who has no delinquent balances with the Company is eligible to elect the Green Power Rider. A Customer may terminate participation of the Green Power Rider at any time and may be terminated from the Green Power Rider by the Company if the Customer becomes subject to collection action on this service account. Once a Customer's participation in the Green Power Rider for twelve (12) months following the date of termination. Resale of service is not permitted hereunder.

MONTHLY RATE

Customers taking service under this rider shall pay a \$9.75 monthly charge in addition to charges applied under the Residential Service (RS-1) rate schedule. The charge under this rider may be changed in future conservation cost recovery proceedings. All other applicable charges, including, but not limited to the custome charge, base energy charge, fuel cost recovery, capacity cost recovery, conservation cost recovery and environmental cost recovery will be based on the Customer's otherwise applicable RS-1 rate schedule. Upon election of the Green Power Rider, the Green Power charge will not be provated if the billing period is for less than a full month. Upon termination of the Green Power Rider, no Green Power charge will be assessed in the month in which service is terminated if the billing period is for less than a full month.

TERM OF SERVICE

Not less than one (1) billing period

SPECIAL PROVISIONS

A Customer moving from one service address to another may have the Green Power Rider election transferred from the former to the new address

RULES AND REGULATIONS

Service under this rider is subject to orders of governmental bodies having jurisdiction and to the currently effective "General Rules and Regulations for Electric Service" on file with the Florida Public Service Commission. In case of conflict between any provisions of this schedule and said "General Rules and Regulations for Electric Service" the provisions of this rider shall apply
