RE: **TransNet Connect, Inc. (TJ292)**

Dear Ms. Jansen:

On July 10, 2003, I called the company and spoke with Mr. Stan Crews about nonpayment of the 2002 Regulatory Assessment Fee. At that time, Mr. Crews stated that the company was going out of business and no longer needed a certificate. He indicated that he would write a letter requesting cancellation of the company's certificate.

A letter was not received; therefore, on August 7, 2003, Docket No. 030772-TI was established against TransNet Connect, Inc. for apparent violation of Rule No. 25-4.0161, Florida Administrative Code. Then, on October 13<sup>th</sup>, the Commission received notice that TransNet Connect, Inc. had filed for Chapter 7 bankruptcy protection on October 1, 2003. Florida Public Service Commission records show that TransNet Connect, Inc. is registered in Florida as an IXC carrier.

If the company no longer exists and has need of its IXC registration, can you request cancellation of the tariff and removal from the register due to the bankruptcy and ask that any unpaid Regulatory Assessment Fees be written off? If the company wishes to keep its name on the register and its tariff on file, I will close Docket No. 030772-TI without taking further action.
