AT&T consents to the extension requested herein. In support of its Motion, BellSouth shows the Commission that:


1. The Staff filed its Recommendation in this case on September 4, 2003.
2. At its Agenda Conference on September 16, 2003, the Commissioners assigned to this case voted to adopt the Staff Recommendation.
3. The Commission issued its Order adopting Staff Recommendation on September 30, 2003.
4. Pursuant to Florida Administrative Code, BellSouth has only seven (7) calendar days to file its response to AT&T's motion for reconsideration.
5. BellSouth's counsel has travel and other conflicts over the next several days and needs additional time to prepare BellSouth's response to AT&T's motion.

6. BellSouth's counsel has contacted counsel for AT&T and AT&T's counsel stated that AT&T agrees to the extension of time requested in this motion.
