

The Division of the Commission's Clerk and Administrative Services has forwarded your account to our office to address the nonpayment of the Regulatory Assessment Fees (RAFs) required by Section 364.336. As specified above, pursuant to Section 364.285. Florida Statutes, the Commission may impose a fine or cancel your certificate. Therefore, it is important that you address this matter now.
