1. Marcus, Santoro & Kozak, P.C. ("MS&K"), counsel for the Debtors, filed its Final Application by Marcus, Santoro & Kozak, P.C. for Allowance of Compensation (the "MS&K Application") requesting approval of fees for MS&K in the amount of \$15,124.50, and reimbursement of expenses incurred by MS&K of \$1,629.54, for a total award of \$16,754.04, for the period of April 16, 2003 through October 8, 2003.

2. Troutman Sanders LLP ("T&S"), counsel for the Official Unsecured Creditors Committee, filed its Final Application of Counsel for the Official Unsecured Creditors Committee for Allowance of Compensation (the "T&S Application") requesting approval of fees for T&S totaling \$1,525.00 for the period December 1, 2002 through date of hearing on the T&S Application.

3. The Debtors filed an Application of the Debtors for Allowance of Compensation to Daniel W. Hargrave, CPA (the "Hargrave Application"), an accountant for the Debtors, requesting approval of fees for Daniel W. Hargrave, CPA totaling \$7,500.00.

4. The Debtors filed a Final Application by Debtors for Allowance of Compensation to KPMG LLP (the "KPMG Application"), also an accountant for the Debtors, requesting approval of fees for KPMG LLP totaling \$22,000.00 for the period February 27, 2001 through August 3, 2001.
