The purpose of this letter is to apprise the Commission of an agreement between BellSouth Telecommunications, Inc. ("BellSouth"), and Time Warner Telecom of Florida, L.P. ("Time Warner"), concerning discovery issues in the above referenced proceedings.

On November 3, 2003, BellSouth served its First Set of Interrogatories and First Requests for Production of Documents on Time Warner in Docket No. 030851-TP. On November 5, 2003, BellSouth served its Second Set of Interrogatories and Second Requests for Production of Documents on Time Warner in Docket No. 030852-TP. The parties have agreed that, in lieu of the referenced requests, Time Warner will respond to the discovery requests propounded by the Florida Public Service Commission in its Triennial Review Order proceeding. Pursuant to this agreement, Time Warner will provide responses to requests relating to switching on November 14, 2003 and will provide responses to requests relating to loops and transport on December 1. As a result, BellSouth's discovery requests to Time Warner filed November 3, 2003 and November 5, 2003 are hereby withdrawn.
