Dear Mr. Altamirano:

We've talked several times concerning the above docket, which was established for nonpayment of the 2002 Regulatory Assessment Fee (fee), statutory late payment charges, along with the balance of the 2001 fee. On September 9, 2003, you advised me that you thought the fee had been paid and that you wanted to resolve this docket. On October 6, 2003, I faxed all the information necessary to resolve this docket. As of this date, the Commission has not received payment and settlement proposal. Just as information the 2003 Regulatory Assessment Fee return notice will be mailed in mid-December and become due in a little over three months.

In researching the company further, I discovered that the Florida Department of State, Division of Corporations administratively dissolved The Mobile Phone Company, Inc. on September 19, 2003, for not filing its annual report. Therefore, if the company decides to resolve Docket No. 030619-TX, it would also need to first reactivate The Mobile Phone Company, Inc. with the Division of Corporations.

In Order to resolve this docket, the company must:

- Pay the \$10.16 past due balance of the 2001 fee;
- Complete the 2002 return;
- Pay the 2002 fee, including statutory late payment charges;
- Provide the additional information requested by the Commission's Division of Consumer Affairs concerning Complaint No. 517641T (Customer: Genie Shayne); and
- Reactivate The Mobile Phone Company, Inc. with the Florida Department of State, Division of Corporations.


