On October 6, 2003, Order No. PSC-03-1105-PAA-TX was issued, which required payment of the 2001 and 2002 Regulatory Assessment Fees, along with statutory late payment charges. The Order stated that protests must be received by the Commission by the close of business on October 27, 2003. Due to a scrivener's error, the Order did not mention that a \$1,000 fine had also been imposed by the Commission and the omission was corrected on October 21, 2003, by the Office of the General Counsel issuing an amendatory Order.

On October 27, 2003, the Commission received Fusion Telecom's payment for the 2001 and 2002 Regulatory Assessment Fees (no late payment charges for 2002). In addition, via fax, the Commission received a letter from you requesting that the docket be dismissed since the company had complied with the Order. The Order referenced in your letter was the amendatory Order, which imposed the 1,000 fine (the 1,000 fine was not received). As information, the Commission does <u>not</u> accept faxed filings, therefore, your faxed letter was not considered a timely response to the Proposed Agency Action Orders.

To avoid further confusion, on November 6, 2003, Order No. PSC-03-1252-PAA-TX was sent out, which reissued the Proposed Agency Action Order, to state that a \$1,000 fine had been imposed and to correct the fact that the company did not owe the 2001 Regulatory Assessment Fee. This not only corrected the previous errors, but gave the company additional time to fully respond. The new protest period ends November 27, 2003.

In order to resolve this docket, the company must:

- Pay the \$17.00 statutory late payment charges for 2002;
- Propose a settlement in lieu of the \$1,000 fine imposed, or pay the \$1,000 fine; and
- Request a refund of the company's double payment of the 2001 Regulatory Assessment Fee.

Dear Ms. Bayo:

The Mobile Phone Company, Inc. ("MPC") hereby notifies the Florida Public Service Commission of its request to keep The Mobile Phone Company's ALEC Certificate No. 5742 active. MPC is proposing a settlement amount of \$500.00 to resolve Docket No. 011146-TX. In addition, MPC has filed the Regulatory Assessment Fee Return ("RAF") and paid all past due regulatory assessment fees, plus penalty and interest charges for the calendar period ending December 31, 2000.

Upon review of the applicable laws and regulations of the State of Florida, The Mobile Phone Company has implemented operational and procedural controls to ensure future Regulatory Assessment Fee Returns are filed in a complete, accurate and timely manner. The new procedures and systems implemented should ensure timely filings of future RAF returns and prevent future late payments of regulatory assessment fees.

Furthermore, MPC agrees to a waiver of objection to the administrative cancellation of the company's certificate in the event its offer is accepted and it fails to comply with the terms which it has offered. If, however, there is a factual dispute as to the manner or level of compliance with any provision in the settlement, Commission staff will bring the matter to the Commission for consideration.
