CASE BACKGROUND

- May 9, 2003 Staff received a complaint regarding a prepaid phone card. The prepaid calling services provider listed on the card was IBGH Communications, LLC (IBGH). Staff determined that IBGH had not obtained a certificate of public convenience and necessity (certificate). At that time, Commission rules required that intrastate interexchange telecommunications companies (IXCs) providing services within the state obtain a certificate.
- May 20, 2003 Staff mailed a certified letter (Attachment A) to IBGH requesting that the company investigate the complaint filed against it. Within that letter, staff also notified the company of its requirement to obtain an IXC certificate. The deadline for IBGH to submit the IXC certificate application was June 16, 2003. According to the certified mail receipt

(Attachment B), the letter was received by IBGH on May 28, 2003.

- July 21, 2003 Staff mailed a second certified letter (Attachment C) to IBGH to inform the company of the changes in the Florida law that no longer require IXCs proving services within the state to obtain a certificate. This letter also informed the company that despite these changes, the law does still require IXCs providing services within Florida to file a tariff and to provide the company's current contact information to the Commission. According to the certified mail receipt (Attachment D), the letter was received by IBGH on July 28, 2003. IBGH was required to submit the requested information by August 4, 2003.
- September 2, 2003 Staff opened this docket to address IBGH's apparent violation of Sections 364.02 and 364.04, Florida Statutes.
- September 29, 2003 Staff received a fax (Attachment E) from IBGH's attorney, Mr. Patrick Crocker, Esq., requesting a deferral of this docket from the September 30, 2003, Agenda in order to allow additional time for IBGH to comply with Sections 364.02 and 364.04, Florida Statutes.
- October 14, 2003 Staff held a conference call with Mr. Crocker to discuss the issues addressed in this docket. After the conference call, staff faxed and mailed a follow up letter (Attachment F) to Mr. Crocker. The letter restated the issues discussed during the call. IBGH was required to submit a proposed settlement offer by October 22, 2003, to resolve the apparent violation of Sections 364.02 and 364.04, Florida Statutes. The company was also required to file a tariff, register with the Commission, and resolve the customer complaint by November 3, 2003.
- October 22, 2003 Staff received a proposed settlement offer (Attachment G) from IBGH via facsimile.
- November 4, 2003 The original settlement offer letter was received along with the company's IXC registration, tariff, and the company's response to the customer's complaint. These items are all included in the docket file identified as Document No. 10954. Docket No. 031032-TI was also opened to

acknowledge IBGH's registration as an IXC and the company was assigned registration number TJ855.

The Commission is vested with jurisdiction over this matter pursuant to Sections 364.02(13), 364.04, and 364.285, Florida Statutes. Further, staff's recommendations are consistent with previous Commission actions in dockets for similar types of apparent rule violations, such as, the failure to obtain a certificate. Accordingly, staff believes the following recommendations are appropriate.

ISSUE 1: Should the Commission accept IBGH's proposed settlement offer of \$5,000 to resolve the apparent violation of Sections 364.02 and 364.04, Florida Statutes?

RECOMMENDATION: Yes. The Commission should accept IBGH's proposed settlement offer of \$5,000 to be deposited into the General Revenue Fund for apparent violation of Sections 364.02 and 364.04, Florida Statutes. The payment should be received by the Commission within fourteen calender days after the issuance of the Consummating Order and should identify the docket number and the company's name. Commission should forward the payment to the Department Financial Services for deposit into the General Revenue Fund. Ιf the company fails to pay in accordance with its proposal, then the company's tariff should be canceled and registration number TJ855 should be removed from the register. If the company's tariff is canceled and registration number TJ855 is removed from the register, then the company should be required to immediately cease and desist providing intrastate interexchange telecommunications services in Florida. (Curry, Susac)

STAFF ANALYSIS: As outlined in the case background, after receiving a customer complaint staff determined that IBGH was providing intrastate interexchange telecommunications services within the state. Staff then notified IBGH, via certified mail, of its requirement to obtain an IXC certificate. After not receiving an IXC certificate application from IBGH, staff sent a second certified letter to the company. This letter was sent after the passage of the Tele-Competition Innovation and Infrastructure Enhancement Act (Tele-Competition Act) and informed the company that it was no longer required to obtain an IXC certificate, but it was still required to file a tariff and to provide the company's current contact information to the Commission. Staff requested that IBGH file a tariff and provide the company's current contact information to the Commission by August 4, 2003. receiving a response to the second letter, staff opened this docket to recommend that the Commission impose a penalty of \$25,000 upon IBGH for its apparent violation of Sections 364.02 and 364.04, Florida Statutes.

On September 29, 2003, IBGH requested that this docket be deferred from the September 30, 2003 Agenda to allow the company additional time to comply with Sections 364.02 and 364.04, Florida Statutes. To resolve the apparent violation of Sections 364.02 and 364.04, Florida Statutes, the company proposed a settlement of

\$5,000. The settlement offer was submitted to staff on October 22, 2003. IBGH also agreed to register with the Commission and file a tariff. The company's registration form and tariff were received by the Commission and Docket No. 031032-TI was opened to acknowledge the registration of IBGH as an intrastate interexchange telecommunications company on November 4, 2003. In addition to that, the company has also resolved the customer complaint that initiated this matter.

The monetary amount of IBGH's settlement proposal is consistent with settlement offers that the Commission has accepted for similar types of apparent rule violations, such as, the failure to obtain a certificate. Further, the company has resolved the customer complaint that initiated this matter, and in Docket No. 031032-TI, the Commission acknowledged that the company is registered as an intrastate interexchange telecommunications company and has filed a tariff. Therefore, staff believes that IBGH has taken the necessary actions to correct the problems causing the apparent violation of Sections 364.02 and 364.04, Florida Statutes and the Commission should accept the company's settlement proposal.

ISSUE 2: Should this docket be closed?

RECOMMENDATION: No. If the Commission approves staff's recommendation on Issue 1, this docket should remain open pending the receipt of the \$5,000 settlement payment. Upon receipt of the payment, it should be forwarded to the Division of Financial Services for deposit into the General Revenue Fund, and this docket should be closed administratively. (Curry, Susac)

STAFF ANALYSIS: If the Commission approves staff's recommendation on Issue 1, the Order issued from this recommendation will become final upon issuance of a Consummating Order, unless a person whose substantial interest are affected by the Commission's decision files a protest within 21 days of the issuance of the Proposed Agency Action Order. This docket should remain open pending the receipt of the \$5,000 settlement payment. Upon receipt of the payment, it should be forwarded to the Division of Financial Services to be deposited into the General Revenue Fund, and this docket should be closed administratively. If the company fails to make payment, this docket should be closed administratively upon the cancellation of the company's tariff and the removal of the company's registration number from the register.

Dear Sirs:

The Florida Public Service Commission recently received the enclosed complaint filed against IBGH Communications, LLC (IBGH), regarding the purchase of a prepaid phone card titled "Hola! Miami." The complaint was filed by Ms. Gabriela Iglesia on May 9, 2003. According to Ms. Iglesia, she purchased a 500 minute phone card but was only able to use the card for 60 minutes. The prepaid calling service provider listed on the card is IBGH. At this time, I ask that you please investigate this complaint, contact Ms. Iglesia, and provide me with a detailed response by **June 8, 2003**, that addresses the issues of this complaint and verifies that Ms. Iglesia has been contacted and her issues resolved.

After receiving Ms. Iglesia's complaint, I found that IBGH has not obtained the proper certification needed to provide prepaid paid calling services (PPCS) within the state of Florida. Rule 25-24.910, Florida Administrative Code (F.A.C.), Certificate of Public Convenience and Necessity Required, states:

A company shall not provide PPCS without first obtaining a certificate of public convenience and necessity as a local exchange company, alternative local exchange company, or interexchange company. The name used as the provider of PPCS printed on the prepaid calling card shall appear identical to the name in which the certificate is issued. A "doing business as" name may be used in lieu of the certificated name if it is registered as a fictitious name with the Florida Division of Corporations and reflected on the certificate before the name is used on the card.

To resolve the certification matter, please file an application with the Florida Public Service Commission to obtain an interexchange company (IXC) certificate no later than **June 16, 2003**. You can find the IXC certificate application package with instructions on our website at, www.floridapsc.com. You may fax your response to Ms. Iglesia's complaint to me at (850) 413-

Please understand that if IBGH Communications, LLC is providing prepaid calling services, and fails to obtain a certificate, it may be subject to a penalty as prescribed by Section 364.285, Florida Statutes, which states:

The commission shall have the power to impose upon any entity subject to its jurisdiction under this chapter which is found to have refused to comply with or to have willfully violated any lawful rule or order of the commission or any provision of this chapter a penalty for each offense of not more than \$25,000, which penalty shall be fixed, imposed, and collected by the commission; or the commission may, for any such violation, amend, suspend, or revoke any certificate issued by it. Each day that such refusal or violation continues constitutes a separate offense.

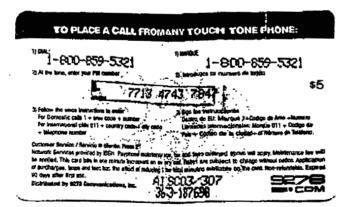

On June 3, 2003, staff received the green certified postal receipt, signed by Sajid Shuikh, indicating the letter was received by IBGH. The deadline for you to reply to the letter was June 8, 2003. To date, our records indicate that IBGH has not submitted a response. Staff requests that you investigate Ms. Iglesia's complaint and submit a written response verifying that Ms. Iglesia has been contacted and that her complaint has been resolved. You may fax your response to me at (850) 413-6663, or you may respond by email to kcurry@psc.state.fl.us.

In the May 20, 2003, letter staff also advised you of IBGH's requirement to file an application with the Florida Public Service Commission (Commission) to obtain an interexchange company (IXC) certificate. 2.4 Interruption of Service

- 2.4.1 Credit allowance for the interruption of service which is not due to the Company's testing or adjusting, negligence of the customer, or due tp the failure of channels or equipment provided by the customer, are subject to the general liability provisions set forth in Subsection 2.3.1. It shall be the customer's obligation to notify the Company immediately of any service interruption for which a credit allowance is desired. Before giving such notice, the customer shall ascertain that the trouble is not being caused by any action or omission by the customer within his control, or equipment, if any, furnished by the customer and connected to the Company's facilities. 2.5 <u>Disconnection of Service by Carrier</u>

The company (carrier), upon 5 working days written notice to the customer, may discontinue service or cancel an application for service without incurring any liability for any of the following reasons:

- 2.5.1 Non-payment of any sum due to carrier for regulated service for more than thirty days beyond the date of rendition of the bill for such service.

When the called party picks up is determined by hardware answer supervision in which the local telephone company sends a signal to the switch or the software utilizing audio tone detection. When software answer supervision is employed, up to 60 seconds of ringing is allowed before it is billed as usage of the network. A call is terminated when the calling or called party hangs up.

3.1.2 Billing Increments

The minimum call duration for billing purposes is 1 minute for a connected call and calls beyond 1 minute are billed in 1 minute increments.

3.1.3 Per Call Billing Charges

Billing will be rounded up to the nearest penny for each call.

There shall be no charges for uncompleted calls.

3.2 Calculation of Distance

Usage charges for all mileage sensitive products are based on the airline distance between rate centers associated with the originating and terminating points of the call.

3.4.1 Bogus Long Distance Service

Bogus Long Distance Service is offered to residential and business customers. The service permits direct dialed outbound calling at a single per minute rate. Service is provided from presubscribed, dedicated or shared use access lines. Calls are billed in one minute increments. No monthly recurring charges or minimum monthly billing requirements apply.

3.4.2 Bogus 800/888 (Inbound) Long Distance Service

Bogus 800/888 (Inbound) Long Distance Service is offered to residential and business customers. The service permits inbound 800/888 calling at a single per minute rate. Service is provided from presubscribed, dedicated or shared use access lines. Calls are billed in six second increments, with a six second minimum call duration. A \$10.00 minimum monthly billing requirement applies. Customers whose monthly usage is less than the minimum will be billed the minimum amount.

3.4.3 Bogus Calling Card Service

Bogus Calling Card Service is a calling card service offered to residential and business customers who subscribe to the Bogus Long Distance Service calling plan. Customers using the Carrier's calling card service access the service by dialing a 1-800 number followed by an account identification number and the number being called. This service permits subscribers utilizing the Carrier's calling card to make calls at a single per minute rate. Calls are billed in one (1) minute increments after the initial minimum period of one (1) minute. There are no nonrecurring or monthly recurring charges.

3.4.4 Operator Services

The Company's operator services are provided to residential and business customers who "presubscribe" to this service for intrastate calling. Operator services include the completion of collect, station-to-station, person-to-person, third party billing and credit card calls with the assistance of a Carrier operator. Each completed operator assisted call consists of two charge elements (except as otherwise indicated herein):
(i) a fixed operator charge, which will be dependent on the type of billing selected (e.g., calling card, collect or other) and/or the completion restriction selected (e.g., station-to-station or person-to-person); and (ii) a measured usage charge dependent upon the duration, distance and/or time of day of the call.

3.4.4.A Operator Dialed Surcharge

This surcharge applies to calls when the customer has the capability of dialing all the digits necessary to complete a call, but elects to dial only the appropriate operator code and requests the operator to dial the called station. The surcharge does not apply to:

- Calls where a customer cannot otherwise dial the call due to defective equipment or trouble on the Bogus Communication, Inc. network; and
- 2) Calls in which a Company operator places a call for a calling party who is identified as being handicapped and unable to dial the call because of his/her handicap.

The Operator Dialed Surcharge applies in addition to any other applicable operator charges.

NOTE: Operator service from payphones or all aggregator locations must comply with the rate caps in sections 25-24.630 and 25-24.516, F.A.C for nonprescribed customers.

4.5 Determining Applicable Rate in Effect

For the initial minute, the rate applicable at the start of chargeable time at the calling station applies. For additional minutes, the rate applicable is that rate which is in effect at the calling station when the additional minute(s) begin. That is, if chargeable time begins during the Day Period, the Day Rate applies to the initial minute and to any additional minutes that the call continues during the rate period. If the call continues into a different rate period, the appropriate rates from that period apply to any additional minutes occurring in that rate period. If an additional minute is split between two rate periods, the rate period applicable at the start of the minute applies to the entire minute.

4.6 Payment of Calls

4.6.1 Late Payment Charges

A late payment Charge of 1.5% per month will be assessed on all unpaid balances more than thirty days old.

4.6.2 Return Check Charges

A return check charge of \$25.00 will be assessed for checks returned for insufficient funds if the face value does not exceed \$50.00, \$30.00 if the face value does exceed \$50.00 but does not exceed \$300.00, \$40.00 if the face value exceeds \$300.00 or 5% of the value of the check, which ever is greater.

4.7 Restoration of Service

A reconnection fee of \$25.00 per occurrence is charged when service is re-established for customers who had been disconnected for non-payment.

4.8 Special Promotions

The company will, from time to time, offer special promotions to its customers waiving certain charges. These promotions will be approved by the FPSC with specific starting and ending dates, and be made part of this tariff.

4.9 Special Rates For The Handicapped

4.9.1. Directory Assistance

There shall be no charge for up to fifty calls per billing cycle from lines or trunks serving individuals with disabilities. The Company shall charge the prevailing tariff rates for every call in excess of 50 within a billing cycle.

4.9.2. Hearing and Speech Impaired Persons

Intrastate toll message rates for TDD users shall be evening rates for daytime calls and night rates for evening and night calls.

4.9.3. <u>Telecommunications Relay Service</u>

For intrastate toll calls received from the relay service, the Company will when billing relay calls discount relay service calls by 50 percent off of the otherwise applicable rate for a voice nonrelay call except that where either the calling or called party indicates that either party is both hearing and visually impaired, the call shall be discounted 60 percent off of the otherwise applicable rate for a voice nonrelay call. The above discounts apply only to time-sensitive elements of a charge for the call and shall not apply to per call charges such as a credit card surcharge.
