Dear Mr. Dye:

Docket No. 030760-TI was established on August 5, 2003, for nonpayment of the 2002 Regulatory Assessment Fee, which was due by January 30, 2003. On August 12th, Yvonne (last name unknown) called and stated that the company wished to keep its certificate active and asked me to fax her the information explaining how to resolve this docket, along with the Regulatory Assessment Fee returns for both your Interexchange Carrier (IXC) and Shared Tenant Service (STS) certificates. The returns and information were faxed the same date. As of this date, the 2002 fees remain unpaid. In addition, Docket No. 031012-TS was established recently for nonpayment of the 2002 Regulatory Assessment Fee on the company's STS certificate.

As information, in other similar cases, the Commission has imposed \$1,000 fines against companies that have violated the Regulatory Assessment Fee rule twice, which is the case here.

In order to resolve this docket, the company must:

- Complete and send the 2002 Regulatory Assessment Fee return;
- Pay the 2002 Regulatory Assessment Fee, along with statutory late payment charges; and
- Propose a settlement in lieu of the \$1,000 fine.
