**MASTER INTERCONNECTION AND RESALE AGREEMENT**

**FOR THE STATE OF FLORIDA**

**BETWEEN**

**Business Telecom, Inc. d/b/a BTI**

**and**

**Sprint – Florida, Incorporated**

This Interconnection and Resale Agreement ("Agreement"), entered into this 9<sup>th</sup> day of June 2003, is entered into by between Business Telecom, Inc. d/b/a BTI a Florida CLEC ("CLEC"), and Sprint – Florida, Incorporated, a Florida corporation ("Sprint"), herein collectively, "the Parties," to establish the rates, terms and conditions for local interconnection, local resale, purchase of unbundled network elements and collocation for the State of Florida.

**NOW THEREFORE**, the Parties agree as follows:

**1. CONDITIONS**

- 1.1 The Parties agree that the Agreement between the Parties shall consist of the Master Interconnection and Resale Agreement for the State of Florida entered into by and between Sprint and MCImetro Access Transmission Services LLC, dated March 1, 2002 - February 28, 2005 ("Adopted Agreement"), amended as noted herein.

**2. TERM**

- 2.1 This Agreement shall be in force and become effective June 9, 2003, or the date of Commission approval, if required.
- 2.2 This Agreement shall have a termination date of February 28, 2005, which corresponds with the termination date of the Adopted Agreement.

**3. PARTIES**

- 3.1 Business Telecom, Inc. d/b/a BTI is hereby substituted in the Adopted Agreements for MCImetro Access Transmission Services LLC. Sprint shall remain as the other Party to the Agreement. Except as modified herein, this Agreement shall in all other respects reflect the same terms as the Adopted Agreement.
