THIS INDENTURE, made this 30th day of December, 2002,



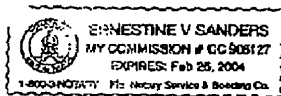
