On behalf of ICG Telecom Group, Inc., I am submitting ICG's response to the data request that ICG received from Staff. ICG has checked the box designated for carriers who do not provide services or provide services through resale. While the box does not describe ICG's situation precisely, it appears to be the appropriate selection for carriers to whom the data request is inapplicable for reasons other than those identified on the form. To explain its selection, ICG is including this additional statement, which is part of its response.
