Dear Ms. Bayo:

Peoples Gas System ("Peoples" or the "Company") has, by letters dated October 7 and November 19, 2003, accommodated requests by the Commission Staff for the Company's waiver of the 60-day requirement for Commission action on the Company's tariff filing in the above docket (under the file-and-suspend statute), so the tariff filing could be considered at later agenda conferences. The Company has now received yet another request that it waive the statutory time period so the tariff filing may be further deferred from the December 16, 2003 agenda to the agenda for January 6, 2004.

Reluctantly, Peoples hereby again waives the 60-day requirement for Commission action on the Company's tariff filing in the above docket (under the file-and-suspend statute), subject to the Commission's taking action on such tariff filing at its January 6, 2004 agenda conference.

We trust this third conditional waiver will accommodate the Commission Staff's desire to have the Company's tariff filing in the above docket considered by the Commission on January 6, 2004, rather than on December 16, 2003.


