Thank you. FYI the FL Water/Lee County transfer in #030932-WS only part of the Lee County system was transferred so the certificates (#306-W and 255-S) were amended - not cancelled. The remaining system in Lee County is the Burnt Store system which crosses into Charlotte County. By this docket the Burnt Store system as well as the Deep Creek system (entirely in Charlotte County under Certificates #570-W and 496-S) are being transferred to Charlotte County.
