**BELLSOUTH TELECOMMUNICATIONS, INC.'S
MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, Inc. ("BellSouth"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant BellSouth a seven (7) day extension of time or until January 6, 2004, in which to file a response to Supra Telecommunications and Information Systems, Inc.'s ("Supra") Motion for Reconsideration of Commission Order No. PSC-03-1392-FOF-TP. In support of this motion, BellSouth states the following:

1. On December 23, 2003, Supra filed its Motion for Reconsideration of Commission Order No. PSC-03-1392-FOF-TP ("Motion") in the captioned docket. Supra served their Motion on BellSouth via facsimile on that same date. Accordingly, under Rules 28-106.204(5) and 28-106.103, Florida Administrative Code, BellSouth's response to Supra's Motion is due on December 30, 2003, (seven days (7) days from service).
2. Due to travel and the holidays, BellSouth needs additional time to prepare a response to Supra's Motion.
3. The Parties would not be prejudiced by a seven (7) day extension of time.


4. BellSouth has contacted counsel for Supra to ascertain Supra's position as to BellSouth's request. Supra informed BellSouth that it does not object to BellSouth's request for an extension.

5. Due to the fact that BellSouth's response is due on December 30, 2003, BellSouth requests expedited treatment of the instant Motion.


