TALLAHASSEE – The following issues are among those scheduled for consideration during the December 17, 2002 Agenda Conference.

**ITEM 3 - DOCKET NO. 021061-TP - PETITION OF CNM NETWORKS, INC. FOR DECLARATORY STATEMENT THAT CNM'S PHONE-TO-PHONE INTERNET PROTOCOL (IP) TELEPHONY IS NOT "TELECOMMUNICATIONS" AND THAT CNM IS NOT A "TELECOMMUNICATIONS COMPANY" SUBJECT TO FLORIDA PUBLIC SERVICE COMMISSION JURISDICTION.** The Commission will consider a number of legal motions in addition to a staff recommendation to open a generic proceeding to address issues raised in connection with phone-to-phone Internet protocol telephony.

**ITEM 9 - DOCKET NO. 000121B-TP - INVESTIGATION INTO THE ESTABLISHMENT OF OPERATIONS SUPPORT SYSTEMS PERMANENT PERFORMANCE MEASURES FOR INCUMBENT LOCAL EXCHANGE TELECOMMUNICATIONS COMPANIES. (SPRINT-FLORIDA TRACK)** The Commission will consider a staff recommendation to establish permanent performance measures to evaluate operational support systems provided by Sprint to alternative local exchange carriers.

**ITEM 23 - DOCKET NO. 021164-EI - PETITION FOR AUTHORIZATION TO INCREASE RESERVE FOR STORM DAMAGE BY MAKING A ONE-TIME EXPENSE ACCRUAL TO RESERVE BEFORE DECEMBER 31, 2002.** The Commission will consider whether to allow FP&L to make a one-time expense accrual of between \$25 million to \$35 million to increase its Reserve for Storm Damage.
