

## **PSC ADOPTS CHANGES TO POWER PLANT BIDDING RULES**

TALLAHASSEE — Revised bidding rules for investor-owned utilities engaging in power plant construction were adopted by the Florida Public Service Commission (PSC) Friday.

Aimed at creating a more transparent process accessible to a greater number of bidders, the revisions require a utility that issues a request for proposals to divulge in advance the methodology and criteria it will use to evaluate bids and provides a mechanism for expedited dispute resolution.

“Our intention is to create a process that is open and fair to all potential bidders,” Commission Chairman Lila Jaber said. “The benefit to the consumer is a broader opportunity for a utility to select the most cost-effective means of meeting increased demand for power, and that translates into affordable, reliable service.”

Existing Commission rules require investor-owned utilities to issue requests for proposals for capacity additions of more than 75 megawatts that use steam in the generation cycle. Under the revised rules, a utility cannot include terms in its request for proposals that are, “unfair, unduly discriminatory, onerous or commercially infeasible.” The utility issuing the request for proposals must describe in detail how it will evaluate bids it solicits, including any weighting and ranking factors it intends to use to evaluate bids.

Under the revisions adopted Friday, bidders have a mechanism through which objections to a request for proposals can be taken to the Commission to determine if violations of the bidding rule occurred.
