On behalf of Florida Digital Network, Inc. ("FDN"), I write to respond to the above letter Mr. Criser sent you under the guise of advising the collaborative of a possible new wholesale stand-alone DSL offering to ISPs. Mr. Criser's letter was apparently delivered to the Commission before it was delivered to any outside parties. I was only made aware of the letter today by the Commission Staff's Legal Department.

It should not go, and apparently has not been, unnoticed by the Commission that Mr. Criser's letter comes just two business days before the Commission's April 23 vote in Docket No. 010098-TP. In that docket, FDN has requested that the Commission require BellSouth provide ALECs an end-to-end broadband service on the same unbundled loops that ALECs use to provide analog voice service (the "FDN – Bell Arbitration"). As you may be aware, the Commission staff has recommended that the Commission grant FDN's request.

As is apparent from the letter itself, BellSouth's proposal is utterly vague as to the terms, prices, and conditions of the supposed offering. There is absolutely no reason to believe that ALECs could use the offering to actually provide DSL to Florida consumers on a competitive basis. Further, any suggestion that FDN's arbitration request should be put on hold pending further review of this BellSouth "proposal" should be rejected. BellSouth has had years to forge a broadband product that will address the anticompetitive issues ALECs have long complained about, and several times the Commission has from the bench urged BellSouth to find a solution. Yet, on the precipice of a critical Commission decision, BellSouth avoids the real issue and instead proposes something so completely nebulous that it answers nothing and poses no solution.

FDN asserts it would be inappropriate and unlawful for BellSouth to attempt to influence the Commission's vote tomorrow in the FDN – Bell Arbitration. BellSouth knows full well the issues being voted on in the FDN – Bell Arbitration, and the content of Mr. Criser's letter address the merits of that matter. The record in the FDN – Bell Arbitration is closed. BellSouth's letter is not in the Docket No. 010098-TP record, and, therefore, should not and cannot be considered by the Commission. BellSouth's offering can have no effect whatsoever on the Commission's review of the FDN – BellSouth Arbitration case, and FDN reserves its right to claim and seek redress for BellSouth's letter as an unlawful ex parte communication.

Without waiving any of FDN's rights, as indicated above, I have provided a copy of this letter to all persons Mr. Criser listed as copy recipients of his letter.
