On May 12, 2003, the Commission received your letter, which appears to be a request for cancellation of the company's payphone certificate, along with payment of the 2002 Regulatory Assessment Fee. As information, the Regulatory Assessment Fee is assessed if a certificate is active for any day during a calendar year. This means that even though the company may not have had any income from the payphones in 2003, the 2003 fee is still owed.

In order to recommend that the company receive a voluntary cancellation, the company must either pay the 2003 fee or provide a date certain it will be paid in compliance with Rule 25-24.514, Florida Administrative Code. The 2003 Regulatory Assessment Fee return form and the above rule are attached.

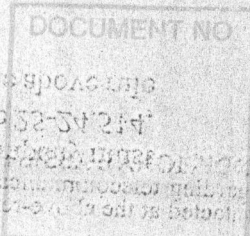
