On June 13, 2003, Intellitec Consulting Inc. d/b/a STS was merged with Saturn Telecommunication Services, Inc. and became inactive. According to the Sec. of State, Div. of Corps., the surviving entity is run by the same person, Jon Krutchik. The above agreement is an IURC and was signed by the Companies on June 18, 2003, and June 25, 2003 respectively, but the CLEC name is shown as the old name. Does this need to be changed? I don't believe it does, but I'd like your input.

According to the agreement, Item 39, appearing on page 21, "Successors and Assigns":

"This agreement shall be binding on and inure to the benefit of the Parties and their respective legal successors and permitted assigns."

Under the above statement (part of the agreement) is it necessary to change the name from Intellitec to Saturn?
